Introducing Pioneer *Giftdirect*

Simplicity

Pioneer *Giftdirect* allows you to benefit the ministry of Pioneer Bible Translators (PBT) and its missionaries without being bothered by the finer points—like remembering the checkbook and stamps or sending in a contribution when you are out of town. You can set up this agreement ahead of time and let it work for you, with one less detail to have to worry about. With this option you authorize your bank to automatically transfer your gift from your bank account to PBT's account each month.

Accountability

Your decision to contribute to your chosen ministry through **Pioneer *Giftdirect***, sets into motion a commitment that will stay consistent until you choose to stop or change it. This may be the accountability you are looking for to avoid falling behind, forgetting your donation, or even just putting it off. **Pioneer *Giftdirect*** is another means for you to connect your monthly budget to the ministry of Bible translation and literacy around the globe.

How Does It Work?

Please complete the attached Bank Authorization Form and mail it to:

PBT bookkeepers will forward the information to Church Development Fund (CDF), administrator of the **Pioneer *Giftdirect*** program. CDF will begin deducting from your account the amount designated (minimum of \$ 25.00) on the date that you choose (10th or

25th of each month). If you desire to change this agreement, you must contact PBT in writing 30 days prior to the change. If you desire to contribute more than once a month, please complete two forms, one for each date on which you want your gift to be made.



PBT will also contact the forwarding agents of the missionaries with whom you partner, notifying them of your **Pioneer *Giftdirect*** participation. Receipts for your tax-deductible contributions will still be mailed to you by the forwarding agents, so you will continue to receive news and updates in the customary way.

You may expect the first fund transfer to occur within 30 days of the time we receive your authorization form. Since PBT missionaries count on your regular contributions and you will not want them to miss a gift while your **Pioneer *Giftdirect*** request is being processed, we recommend that you mail us your **Pioneer *Giftdirect*** form about 35 days before the date on which you want it to become effective.

We value your partnership with us. Thank you for helping us "Bring God's Word to Life" among Bibleless people groups in Africa, Asia, Europe, and the South Pacific.

Bank Authorization Form

I request the Church Development Fund, Inc. (CDF) to withdraw funds from my account at the bank named below for a monthly donation to Pioneer Bible Translators (PBT). Such withdrawal (minimum \$ 25.00) shall be credited as if I had personally made the withdrawal. The authorization shall remain in effect until I notify Pioneer Bible Translators in writing that I wish to end this agreement, which I may do at any time with a minimum of thirty (30) days prior written notice. I agree that neither Pioneer Bible Translators nor Church Development Fund will be liable for transfers made during such thirty-day notice period. I understand that receipts for purposes of tax-deduction are the responsibility of Pioneer Bible Translators and not of Church Development Fund. I agree that this bank authorization and any withdrawals hereunder may be terminated by CDF and/or PBT without cause or notice.
